RENT RECEIPTS

Due to a shortage in our maintenance department, we will no longer be able to deliver your rent receipts to you. We will be filing them in your file. You are welcome to come to the office and pick them up.

WATCH YOUR MAIL FOR RENT STATEMENTS.

COOL WEATHER IS WITH US. PLEASE REMEMBER TO BE CONSERVATIVE. SET YOUR THERMOSTAT NO HIGHER THAN 68 DEGREES WHEN YOU ARE HOME AND LOWER WHEN YOU GO TO SLEEP. TURN OFF ELECTRIC DEVICES YOU ARE NOT USING. RUN THE WASHING MACHINE AT NIGHT AND ON THE WEEKENDS. USE COLD WATER.

IF YOU HAVE ANY HOLES IN DOORS OR WALLS, BROKEN BLINDS, OR OTHER NEEDED REPAIRS, PLEASE CALL THE OFFICE.

DO NOT DUMP COALS ON THE GRASS.

DO NOT DUMP GREASE IN SINKS OR COMMODOES. GREASE SHOULD BE ALLOWED TO COOL THEN PLACED IN A TRASH BAG.

DO NOT FLUSH - Paper towels, wipes, grease, pampers, feminine products, etc. Not even "flushable" wipes.

COMMUNITY SERVICE IS DUE MONTHLY 8 HOURS PER MONTH

TRASH PICK UP CHANGE

TRASH PICK UP FOR ALL FAMILIES IS WEEKLY ON THURSDAYS. PLEASE HAVE YOUR TRASH CANS PULLED TO THE CURB ON WEDNESDAY NIGHT FOR PICK-UP ON THURSDAY. PLEASE ALSO REMEMBER TO PULL YOUR TRASH CAN BACK TO THE BACK OF YOUR APARTMENT AFTER PICK-UP. WHEN THURSDAY IS A HOLIDAY, THE NEXT BUSINESS DAY WILL BE PICK UP DAY.

RENT CHANGES

All income changes (up or down) are to be reported to the office in writing within 10 days. In order for the office to verify your information and make necessary changes these need to be reported no later than the 25th of the month.

PEST CONTROL

We continue to do quarterly pest control for all of your apartments - We are in the process of changing companies. Please watch for a notice as to when your unit will be sprayed.
